Classroom Look and Rules

Here at ISDA we strive for, and therefore require, a uniformed look. It not only looks great, but brings a professional environment into the classroom and the public eye.

Mandatory uniform packages are required at registration for all dancers. Child sizes are \$50, adult sizes \$60. These include leotards, bike shorts for some packages, tights, and all required class shoes. Dancers must come to class with hair pulled up in a nice bun that will not fall out during class, or pull back short hair with clips or a black head band. Please do not wear jewelry or hair accessories that will distract the dancer during class. Wearing class shoes outside is strictly forbidden. Dirt and gravel mark up and damage our floors, so please have your dancer arrive and leave in street shoes. Help your dancer practice proper hygiene habits by wearing deodorant and washing their uniform after every use. Provide your dancer a bag to put their dance accessories in.

Parents are asked to observe their dancer's session outside of the classroom. We have provided viewing windows for all three of our classrooms for parent convenience. We find the students focus more without distractions from those not participating.

Please have your dancer attend class on a regular basis, as well as show up to class on time. Dancers more than five minutes late may be asked not to participate. If you have a dancer age 5 and under, we ask a parent or guardian stay at the studio for the duration of the class. Also, if dropping off a student, please park in a designated parking spot and walk your dancer to the door. Refrain from using the red fire curbs and handicap areas as a drop off location. Our parking lot is frequented by police, and it becomes dangerous for dancers crossing the parking lot.

We teach respect towards instructors and fellow dancers. If dancers misbehave in class, the student may be asked to leave the room for a "time out" and a verbal or written notice will be sent to the parent. We want all students to have a great time in class, so please back up these disciplinary measures!

No food, drinks, gum or dance bags are allowed in the classrooms. We have provided storage space in the back lobby for eating, drinking and placing their belongings. Have your dancer label their shoes with their name and bring them in with them to class without a dance bag (combo students). Please encourage your dancer to keep classrooms, lobby, cubbies and bathroom clean. Please treat our facility like a second home!

If your dancer will be missing any classes, whether for illness, vacation, etc., we would like a phone call or email from a parent the day of class. This will allow instructors to better prepare for their absence and/or rearrange formations for dances if necessary.

If a dancer misses a class, there are opportunities for makeup classes. A makeup must be completed within one month of the absence, and they can attend any class at the same level and time length. You can speak with staff for suggestions and notifying what classes a dancer will be attending for the makeup.

The majority of our mass communication is done via email. We send out a weekly email containing all up-to-date information about news, events and upcoming deadlines. Performance Opportunities

All dancers at ISDA, including our newest and youngest dancers, have several opportunities throughout the year to perform in a full-staged production! This year, we will be offering the following opportunities:

The Nutcracker - ISDA's 6th annual ballet production - December 6-8, 2019

Showcase 2019 - March 14-15, 2020

Annual Ballet 2020 - performance title to be announced at The Nutcracker - June 27-28, 2020

All three of these productions are held at the Bear River High School Performing Arts Theatre, and draw large audiences.

Rehearsals for the productions take place in your dancer's regularly attended weekly class(es). If your dancer's class is combined with another, there may be 1-2 extra rehearsals to join the groups together. Otherwise, dress rehearsal is the only required extra practice, which is held the day before a weekend's performances, at BRHS.

We do required full hair and makeup to be prepared by the parents/guardians prior to dress rehearsal and performance days. You can find information on how to practice and prepare your dancer's look on our website under "How to Prepare for an In Sync Performance".

Deadlines for registering your dancer for the performances are listed on the Annual Calendar included in this packet. Purchase includes a performance fee, professionally tailored costume with tights, and a digital video of the Sunday performance.

Things to expect: dancers will receive their costumes the week of a performance, to ensure the costume stays safe and sparkly for their performance. Parents/guardians will be required to chaperone for their dancer's class backstage for at least one of the shows for a given weekend. Dancers are required to stay backstage for the duration of the entire performance, with a very effective check in/out system to keep track of all the dancers and their safety. All spectators are to purchase tickets to see the performance, but no tickets are required if chaperoning a particular show. The dancer must be available to participate in all of the shows in a performance weekend (Intro to Dance 2-4 years students matinee shows only). Please keep all of this in mind before committing to a performance. All of the hard work and dedication is well worth the reward of seeing your dancer shine on stage!

Kids Helping Kids Foundation and the NorCal Performance Ballet Company

KHKF consists of Company performers, parents, and family members. We are now 200+ members strong and growing, and new members are always welcome! Come join us in achieving our community goals and what we stand for. KHKF is dedicated to raising awareness of the Arts in the region while at the same time achieving funding opportunities for a very important cause... children in need right here in our own community. With almost no overhead or administrative expenses – thanks to many dedicated members who bring energy, the spirit of volunteerism, and a variety of resources – all funding raised by the Foundation goes right back into our community.

KHKF is currently in partnership with *Keaton's Child Cancer Alliance*, a local non-profit stationed in Rocklin that helps children in Northern California with cancer and the trials they and their families face. Every dollar raised in the lobby of our three annual productions goes straight to this amazing charity!

ISDA has achieved a secondary goal through its efforts, and just as rewarding as our first. Our charitable activities and hands-on learning experiences are growing better, altruistic adults for tomorrow. KHKF is the only local NPO that offers youth performers the chance to give back to the community. Our students are developing a bright future as loving, sharing, giving and responsible community volunteers.

The NorCal Performance Ballet Company is ISDA's pre-professional ballet program, in affiliation with the Kids Helping Kids Foundation. Curriculum includes rigorous ballet training with supplemental classes in stretch and conditioning, choreography, as well as technical and performance skills, all essential to an overall comprehensive dance education. Technique is geared towards pre-professional preparation, including

transitional opportunities at the high school level to move into the professional realm of dance. The ideal training program for the dancer looking to pursue dance through college scholarship applications and dance teams, or a future professional career in ballet and beyond.

Dancers gain the opportunity to perform in two full-length ballet productions every year through ISDA; our annual holiday performance of The Nutcracker, as well as our all-original ballet in June. NCPB students earn more prominent roles in these productions, and participate in extra weekly rehearsals in preparation.

Dancers wishing to be a member of the KHKF and NCPB are required to audition for correct level placement.

Auditions are held once a year in August.
